

- 設施或土地租賃契約書或相關證明文件。
- 5. 申請人證明文件
 - (1) 公司登記證明文件。
 - (2) 新投資創設者,其公司名稱、所 營事業登記預查核准文件及下 列代表人證件:
 - 本國人:國民身分證影本。
 - 僑民:僑民身分證明文件。
 - 外國人:國籍證明書或當地 國所核發之護照影本。
- 經營業務須經許可者,檢附相關 證明文件。
- 授權代理人辦理者,應附代理人 授權書及身分證(或居留證)影本。


- 1.申請文件齊備 15 日內審查。
- 2.審查後或文件內容補正完備後 15 日內函復申請人審核結果。

Application Process for Free-trade-zone Enterprise

Establishment Permit

Required documents:

- 1. Application form
- 2. A business plan
- The operating procedures for goods control, the on-line operation of goods customs clearance, and accounting operations
- 4. The lease contracts or relevant evidentiary documents regarding the facility or land
- 5. Applicant certificate
 - (1) The incorporation registration documents
 - (2) The name of the company and the pre-inspected documents for incorporation and registration certificate of the business in the case of a newly invested and incorporated company and the representative's certificate
 - Resident: copy of ID Cards
 - Overseas Community: ID certification
 - Foreigner: nationality certification or copy of passport
- Relevant evidentiary documents, if the business activities to be conducted require a special approval
- 7. The power of attorney issued to such attorney together with a photocopy of the attorney's Identification Card or Certificate of Residency shall also be submitted along therewith



Review schedule by the management authority:

- 1. Review qualified application documents within 15 days.
- 2. Issue approval letter within 15 days after documents be inspected or improved.
